Whilst you cannot get full access to journals you can still use **Summon** (from https://www.brad.ac.uk/library) to search to find out what is available and then order interlibrary loans through your public library service.

2 RESEARCH PUBLICATIONS

2.1 General

Many resources are now published in Open Access so you can still read some research information – good places to start are OAISTER (https://www.oclc.org/en/oaister.html) or OpenDOAR (https://www.opendoar.org/) University of Bradford Research is published in Bradford Scholars (https://bradscholars.brad.ac.uk/). RePEc (https://repec.org) is an economics and management platform for OA publishing.

2.2 UK GOVERNMENT POLICY

2.2.1 Government Publications

Free access to a wide variety of publications written by, or commissioned by, UK government departments.

These include consultation papers, Freedom of Information (FIO) reports, policy and guidance reports (many written by independent researchers), research reports, statistics, etc.

The City of London publishes free research publications covering City issues and wider economic matters.

The research papers are divided by themes, for example City industries; competitiveness; corporate responsibility; economic forecasts; EU and regulation; infrastructure; international markets; taxation.

2.6.2UNCTAD

Free access to a wide variety of research papers, publications and statistics from the United Nations Conference on Trade and Development (UNCTAD), the UN body responsible for dealing with international trade.

Publications include World Investment Reports (WIR); Trade and Development Reports (TDR); Information Economy Reports (IER); E-commerce and Development Reports (ECDR); Technology and Innovation Reports (TIR). Also provides UNCTAD Statistical Reports, for example on foreign direct investment; economic trends; world exports, etc.

2.6.3World Bank Open Knowledge Repository

Free access to a wide variety of academic books, research papers and other publications from the World Bank Open Knowledge Repository, providing authoritative information and data about developing countries, reducing poverty and development initiatives in these areas.

It includes more than 13,000 research publications including: World Bank Group Annual Reports; World Development Reports (WDRs), the journal Development Outreach Magazine, plus articles from the World Bank Economic Review (WBER) and the World Bank Research Observer (WBRO).

2.6.4 World Economic Forum

The World Economic Forum publishes research and reports which examine global issues such as sustainability, the environment, education, entrepreneurship, individual industries, the impact of new technologies, scenario planning, etc.

Standalone annual publications include the Global Competitiveness Report, the Global Risks Report and the Global Gender Gap Report.

Reference Desk: contains a useful **Glossary** giving definitions of international business terms, plus interactive **Online Course Modules** on various topics, for example market research; microfinance; entrepreneurship.

Academy: aimed specifically for students and tutors and includes **Course Content Resources** for classroom use, for example case studies, exercises and simulations.
