Module Aims

This module is an important element of the LLM Natural Resources and Environmental Law and Policy because it will enable students to critically analyse and understand climate change law and policy and to develop the skills necessary to apply this in a range of practical contexts.

The module will provide students with an understanding of the key concepts, principles and mechanisms underlying the Climate Change regime as well as the interrelationship between industrial activities, and in particular energy policy and climate change will form a key part of the module.

Reflecting on the UN Sustainable Development Goal 13 which is focused on Climate Action, this module will explore the practical ways to address the global challenge of climate change. It will examine the effectiveness of the international, regional and national legal instruments aimed at tackling climate change. It will examine developments in the field of climate change law and encourage students to reflect on the nature, function, strengths and weaknesses of the existing mechanisms aimed at addressing climate change.

The module helps students to develop the ability to work with their knowledge of legal principles and apply them to new situations in order to arrive at imaginative and innovative solutions and interpretations in climate change law and policy. It will also equip students to have mastery of the subject, conduct effective research and to critically analyse and assess the specific climate change issues and apply this learning in the relevant practical context.

It aims to develop excellent communication skills including writing and legal research skills commensurate with LLM level study and advanced scholarship

This module is also suitable for any other postgraduate programme, where environmental law, energy law, sustainable development as well as natural resources governance would be studied.

Learning, Teaching and Assessment Strategy

Development of a range of transferable skills such as independent study, effective written and oral communication and problem solving The module uses 32 hours of workshops delivered over 12 weeks to support learning and achievement. The workshops will address the key ethical issues, contributing factors and legal concepts and frameworks related to data protection and privacy law and will include a set of structured learning activities (eg, discussion of preread academic materials) that 'scaffold' the learning.

The workshops will also include tasks and discussions on practical aspects of law and ethics, areas of reform and opportunities for further study and self-study.

The learning process is a mix of directed and independent study. Initially you will be directed to study the topics selected by the module team through the provision to you on the virtual learning environment of relevant materials (lecture slides, reading lists etc). The aim of the directed part of the study will be to introduce you to the fundamental legal concepts and principles of the subject area and of relevant learning resources.

Then you will be guided to study the subjects more broadly and independently with the module team setting in the weekly activities research and other tasks, such as search for solution to real life problems and for legal advice to clients, which require independent research and study by you. independent legal research requires drawing on variety of both primary and secondary materials and written and oral presentations by you. It also requires development of legal arguments and evaluations personal to you.

The weekly interaction in class will facilitate written and oral communication with the student and the lecturer through discussion of legal issues and debates.

Oral feedback will be given in the class and opportunities for written feedback will be provided. Tutors will be available to meet you individually (face-to-face or online) if requested to discuss further feedback opportunities and review your progress. Formative assessment will be made available to help you better prepare for the summative assessment

Learning will be directed, supported and reinforced through series of workshops. The sessions will use theoretical discussions and practical applications of cases and case studies to enable students to think critically about international dimensions of climate change law and policy, with oral feedback given in classes. Some of the sessions may be student-led presentations.

The assessment would be suitable to help students achieve all the learning outcomes of the module and would facilitate the achievements of the learning outcomes of the relevant LLM Programmes as follows:
