<p>Undertake an advanced search and critically analyse literature on a specific topic in the discipline and assess its contribution to knowledge;</p> <p>Organise and synthesise that literature in order to write a critical and detailed review of what is known about that topic;</p> <p>Identify gaps in extant knowledge about specific academic and practitioner issues and explain how your doctoral research will contribute to both theory and organisational/management practice.</p>

<p>Undertaking an advanced and systematic search and review of literature on a specific topic in business and management studies;</p> <p>Engage in critiques of, and trends in, research methodologies;</p> <p>Critically engage in current debates in business and management theory;</p> <p>Methods for analysing a large number of publications;</p> <p>Writing a critical and systematic review of literature on a specific topic in business and management studies;</p> <p>Arriving at a conclusion about the current state of knowledge and research in a field;</p> <p>Identifying gaps in knowledge and using this to generate and hone your research aims and objectives.</p>

Learning, Teaching and Assessment Strategy
<p>In this module you will explore how to develop essential advanced doctoral skills in order to critically assess and systematically engage with a the range of literature available on a chosen topic, so that you can critically assess the current state of knowledge about that issue.</p> <p>Practical sessions (synchronous) or seminars will introduce you to methods of systematically searching and critically analysing literature (1, 2, 5 &amp; 7, achieving Aim A). Lectures will introduce you to ways of organising and synthesising literature, so that you can write a detailed and critical review (1 to 4, achieving Aim B).</p> <p>Lectures(synchronous) or tutorials will advise you on how to critically analyse the entire body of existing literature in a field, showing the current state of knowledge in the area, and identifying gaps where knowledge is insufficient (1, 2, 3 &amp; 7, achieving Aims A, B and C).</p> <p>Individual tutorials with your supervisor will help you hone those skills and relate it to your own research (1, 2 and 4 to 8 achieving Aims B and C), as will the coursework you undertake, involving a critical and detailed literature review of a topic of your choice (1 to 8, achieving Aims A, B, and C). This module will provide a solid foundation for the literature review in the DBA thesis, but this will be continually revised and developed as your studies progress.</p> <p>For this module students will write a 5,000 word paper that reviews the literature in an area of business and management studies, which relates directly to their doctoral research.
