Module Aims
<p>This module critically examines how to contribute to developments in business and management studies and impact management/ organisation practices.</p> <p>It aims to help you do that through:</p> <p>A. Developing advanced scholarship skills in writing academic papers for publication;</p> <p>B. Create and interpret new knowledge and empirical research through designing and conducting a pilot study;</p> <p>C. Develop a systematic and critical understanding of the current state of knowledge concerning how to translate research into practice;</p> <p>D. To explore how you will apply advanced knowledge to translating the findings of your own empirical research into management/organisational practice, thus to achieve the core distinction between a DBA and a PhD.</p>

<p>Writing for academic publication: the process; peer review and what editors and reviewers look for;</p> <p>Reviewing skills; Working with reviewers' comments;</p> <p>Undertaking a pilot study;</p> <p>Working with your empirical research findings on an organisation;</p> <p>Theoretical perspectives on translating research into practice;</p> <p>Empirical evidence concerning the translation of research into practice.</p>

Learning, Teaching and Assessment Strategy
<p>This module's learning and teaching consists of two methods: lectures and workshops. Lectures will be delivered by leading academics who review journal articles and will provide detailed insights into the publication process, and what editors and reviewers look for in papers submitted to journals (1, 2, &amp; 7). Lectures will explore the process of taking empirical data and developing it for inclusion in academic papers (1, 2, 3, 4, 7, achieving Aims A and B). Workshops will focus on honing research aims and methodologies to achieve those aims. Lectures will also explore the current evidence about the state of knowledge about translating research into practice (1 to 8, achieving Aims B, C and D).</p> <p>The lectures will also discuss the research ethics approval processes at the University of Bradford.</p> <p>A related group of lectures/practical sessions will demonstrate the process of submitting papers, dealing with rejection, and working with reviewers' comments (1, 2, 3, 4 &amp; 7, achieving Aim A).</p> <p>For this module you are to prepare a submission-ready manuscript (5000-6000 words in length) based upon your DBA/PhD research to date.</p> <p>This manuscript (MS) will need to follow author guidelines from a relevant journal (see below) and should be to a standard of being ready for submission, or near-submittable, to your nominated journal. As described during the module teaching sessions, this journal is of your own choice and should be most relevant to your own research dissertation. The choice of journal is therefore not prescriptive, it is up to you to research and decide upon.</p> <p>The format, style, and length of your MS needs to fit exactly the author guidelines for your nominated journal. This aspect of preparation of your MS therefore needs careful attention in order to avoid a desk-reject for non-compliance to journal standards subsequently. On your assignment please note clearly your nominated journal and give a link to the Author Guidelines webpage for that journal.</p> <p>The aim here is to provide you an opportunity to develop experience in the writing of ms/journals articles in the formal style that you will use when writing your thesis. The module lectures are only the starting point. You should work closely with your supervisor and seek their advice during this process.</p>
