Module Aims

This module will build on Midwifery Practice 2 by developing your knowledge and understanding of the role of the midwife as colleague, scholar and leader. You will have opportunity to participate in complex care planning, responding to vulnerability, supervision and delegation, and management. It will support progression towards achievement of the NMC standards of proficiency for midwives (2019) and preparation to practice safely and effectively at the point of registration. You will complete the requirements for practical and clinical training of midwives (NMC 2019)

Learning, Teaching and Assessment Strategy

During your final year you are expected to provide care for mothers, their babies and their families in partnership with midwives and other health and social care practitioners, with appropriate supervision and direction as your knowledge and skill increases. The expectations of professional behaviour and academic knowledge and skills are specific to your progression as a year 3 student midwife and are documented in your electronic midwifery ongoing record of achievement (e-MORA). This module is delivered alongside the theory modules Questioning Midwifery Knowledge 1 and 2 and Transition to Professional Self 3, which supports the application of theory to practice and opportunities to practise for practice.

Your progress will be assessed in a range of placements as part of a continuous assessment process and should not be viewed as separate elements but reflect the continuum of care provided in partnership with women and their families. Practice Supervisors are required to regularly provide written feedback on your progress and confirm that you are meeting the required professional behaviour standards. This feedback will inform your ongoing development and the holistic assessment that your Practice Assessor will complete (learning outcomes (LOS 1,2).

Two interim interviews will form the formative aspect of this assessment to judge how you are progressing throughout your practice and action plans will be written to help you attain your final goals (LOs1,2).

To consolidate your learning, you will complete a written reflection on an aspect of your practice. Formative feedback on your draft work is available from your personal academic tutor (PAT) (LO 3).

Your progress will be reviewed by your Practice Assessor (PA) in clinical practice and your Academic Assessor (AA) twice formatively (end of semester 1 and 2) and then summatively at the end of each year. The PA and AA will evaluate and recommend you for progression to the next stage of the programme as part of the summative holistic assessment at the end of semester 3 in line with SSSA standards (NMC 2018) and the programme standards. You must pass the summative holistic assessment and complete all programme requirements to be eligible to enter the NMC Part 2 register as a midwife.

Should concern be raised about your ability to meet the required proficiencies in year 3, a tripartite meeting will be arranged with you, your Practice Assessor (PA) and your Academic Assessor (AA). An appropriate action plan will be agreed which enables you to complete within a negotiated timeframe.
