The module will prepare the trainee Nursing Associate to provide effective person centred care in a range of settings.

Holistic care: oral care.

Monitoring care; recognition of deterioration; escalation and reporting; NEWS, PAWS, ABCDE. Aseptic technique.

Medicines Management: Introduction to pharmacology, Local and National medicines policy and legislation, different routes of prescribing, drug allergies and sensitivities, using the BNF.

Sub - cutaneous, IM injections, Insulin.

Skin Integrity: wound care; infection risks; rashes and irritation; assessment of positioning and pressure relief. Mental health first aid.

Nutrition: Monitoring - MUST screening, respond to symptoms of nausea, vomiting, dehydration.

Elimination: constipation, PR examination & safe administration of medication, stoma care, continence assessment and promotion.

Monitor effectiveness of symptom relief interventions: restlessness, agitation, anxiety and depression, Communication, support use of personal aids; manage alternative communication techniques, sensory impairment, reasonable adjustments, professional communication; respond to questioning.

Reflection; using evidence in practice and academic work.
