## Module Aims

The module aims to introduce students to a range of interdisciplinary theoretical approaches, which conceptualized the reciprocal relationship between individuals, groups and social institutions, and the construction and formation of Self- Consciousness and Identity within such structures. Students will explore the tensions and multi-layered complexities of 'Selfhood' and 'Identity' in Sociology and related disciplines. Moreover, throughout the module, there is a particular focus on applications and lived experiences.

Students will learn about the major traditions and figures within the field of Selfhood and Identity; however, seminars will critically discuss and emphasise the modern applications (with reference to contemporary research) of said figures. As this is an interdisciplinary module, we will also explore how 'lived experiences' around self-identity are also reflected and written into literary fiction.

## Outline Syllabus

- 1. The social emergence of the Self in a Global Society.
- 2. Social categorization of the individual and its impact on experiences of Self and Identity.
- 3. The social psychological emergence of concepts such as Selfhood and Identity.
- 4. The Sociological concepts such as Selfhood and Identity.
- 5. Social power structures and the creation of a categorized 'subject,' and strategies of agency.
- 6. Explore the emerging research into the decolonization of western concepts of Self and Identity.
- 7. Exploring Self narratives through society and literature.
- 8. The role of language and media.

Learning, Teaching and Assessment Strategy

Module content is delivered through highly interactive lectures. For example, short-mini lectures are followed by group and/or class discussions, which further analyse, elaborate and apply the learnt content. This encourages students to actively participate, work in teams and challenge / present ideas, to promote deep learning. The teaching method(s) also promotes independent learning, which contributes towards assessment activities. For instance, group discussions support students in their assessment (assessment 2). Suggested reading contributes towards assessment 1.
