Module Aims

To provide a critical introduction to the debates, issues and developments that define and pattern the context of contemporary policing in England and Wales.

The module will also explore the comparisons with and explore ideas drawn from policing systems abroad.

The module aims to make links between theoretical ideas and perspectives on policing and related policies and practices introduced both nationally and locally.

This module will enable students to develop both analytical and written communication skills with specific reference to policing issues.

The syllabus for this module will include exploring:

- the historical and contemporary context of policing

- the governance and accountability of the police service

- policing diversity in contemporary times

- police culture and discretion

- the efficacy of nationally and locally based community models of policing

- the extended policing family, including privatisation and marketization of contemporary services

- victims and the police

- ethical approaches to policing and their implications in a multi-cultural society

Additionally, the syllabus will offer some flexibility to enable discussion of a developing contemporary issue (either nationally or locally), or a development in policing which may be particularly topical or relevant at a given time.

Learning, Teaching and Assessment Strategy

Lectures, seminars, groupwork/discussions and directed study. Eleven one-hour lectures will provide an overview of key debates, issues and developments of international, national and local policing. Eleven one-hour seminars will give the opportunity to discuss research on policing and develop an understanding of key contemporary issues faced by the police today. Directed study requires students to carry out independent reading relevant to the topics covered.

Wherever possible, students will be able to visit police settings and/or have some engagement with the local police service.

Assessment will consist of a report offering a critical review of a police approach or practice explored within the module.
