Module Aims

- To support students' ability to develop a coherent, flexible, creative and academically grounded proposal for their dissertation.
- To provide students with the opportunity to develop problem-solving skills and apply them to social problems and issues.
- To acquire the knowledge/information needed to prepare for the world of work by planning for a final year work placement and in preparation for seeking employment upon graduation.
- To strengthen students' ability to use a strength-based approach and to work flexibly and independently in developing skills and resources.
- To support student presentation of well written, structured, appropriate, analytical and creative work, appropriate to both the dissertation proposal and the employability context.

Outline Syllabus

Research contexts and methodologies; choosing topics and workplaces: finding and reviewing literature reviews; qualitative and quantitative data collection; ethics, academic research and the workplace; library resources; workplace opportunities and challenges including approaches to equality and diversity; time management; applying workplace experiences to academic contexts; understanding organizations; professional approaches.

Learning, Teaching and Assessment Strategy

Lectures will provide knowledge and discussion of key issues relating to both research and employment. Seminars will develop employment or research-related knowledge depending partly on the chosen destination of students in their final year; work placement or academic modules. Library workshops will enhance practical learning skills. Workshops will offer opportunity for student exploration and feedback of specific challenges.

Alongside this, students will undertake guided study as a means of deepening understanding of the topics within the contact sessions and gradually developing expertise in relation to specific elements of the assessment, such as CV-writing and explaining a methodological approach to undergraduate research.

The assessments demonstrate student knowledge related to producing a specific research topic and evaluate knowledge, skills and attributes relevant to workplace contexts. The portfolio must include, but is not limited to:

- Understanding and compliance with regulations for entering work: Currently, focused on Disclosure and Barring policy and practice.
- The context of formal and informal risk assessment in the workplace, including evidence of understanding of safeguarding.
- Evidence of awareness of equality and diversity law and/or practice.
