Module Aims

To explore current roles of police, prisons and probation offender management in contemporary society, foregrounding UK practice.

This module examines penal services in relation to the prevention of crime and of modes of punishment for offenders, including pathways for rehabilitation and resettlement. This will include desistance form crime and approaches to changing criminal behaviour.

The module will enable students to develop current skills and understanding of key principles underpinning offender management and behaviour change.

The material covered will encourage students to evaluate current issues and practice dilemmas.

Outline Syllabus

The syllabus will examine a range of issues relating to the policing and 'end to end' offender management and resettlement systems in the UK and abroad.

These include: current challenges involved in punishment of crime and management of offenders; penal/policing culture and use of 'discretion'; alternatives to imprisonment; pathways to desistance;

rehabilitation and resettlement of offenders, and the rise of community-based models of policing and of punishment.

02	Engage in informed debates in contemporary policing and offender management, rehabilitation and desistance.			
03	Critically appraise current research into desistance and resettlement with a focus on the management of offenders.			
04	Demonstrate links between theory and practice in the management of offenders.			
05	Construct a sophisticated written and oral ability to present offender management issues in theory and practice.			

Learning, Teaching and Assessment Strategy

Whole group lectures will explore current policy and practice in offender management, using external professionals where possible.

Seminars will explore the theoretical context of punsihment, desistance and behaviour change and relate these to current practice issues.

Tutorials will support students independent study by exploring reading and other information sources. Tutorial swill also provide support for individual or small group presentations.

Some elements of this module may be delivered through the University VLE.
